Dear Shareholder:

You are receiving this notification because Angel Wing Metals Inc. ("Angel Wing Metals" or the "Corporation") will be using the notice-and-access model ("Notice-and-Access") provided for under National Instrument 54-101 for the delivery of meeting materials to certain shareholders in respect of the annual general and special meeting to be held on Thursday, June 29, 2023 (the "Meeting").

Under Notice-and-Access, instead of receiving printed copies of the Corporation's management information circular ("Information Circular"), shareholders receive this notice with information on how to access the Information Circular electronically. However, together with this notice, shareholders continue to receive a proxy or voting instruction form ("VIF"), enabling them to vote at the Meeting. Adopting Notice-and-Access to deliver materials is more environmentally friendly as it reduces paper use and also lowers the Corporation's costs for printing and mailing.

- 2. <u>Fix Number of Directors to be Elected at the Meeting</u>: to fix the number of directors of the Corporation to be elected at the Meeting at five (5);
- 3. Election of Directors: to elect the Board of Directors of the Corporation for the ensuing year;
- 4. <u>Appointment of Auditor</u>: to appoint the auditors of the Corporation for the ensuing year and to authorize the Board of Directors to fix the auditor's remuneration;
- 5. <u>Re-Approval of Stock Option Plan</u>: to consider, and if thought fit, approve the ordinary resolution, as more particularly set forth in the accompanying Management Information Circular prepared for the purpose of the Meeting, relating to the re-approval of the stock option plan of the Corporation;
- 6. <u>Consolidation of Shares</u>: to consider, and if thought fit, approve the special resolution as more particularly set forth in the accompanying Management Information Circular prepared for the purpose of the Meeting, relating to the amendment of the Articles of the Corporation in order to consolidate the issued and outstanding common shares of the Corporation on the basis of one (1) post-consolidation Common Share for every two (2) pre-consolidation Common Shares; and
